- Phase 3: (a) Permanent removal of 120L, 120C, 120R and 121L.
  - (b) New 113C, 113R, 114L and 114C.

Exact dates and times of changes will be promulgated by NOTAM with reference to this Supplement.

NOTE: works may be paused during busy summer months to facilitate aircraft stand demand.

During the course of the works, Apron Taxiways F-Inner and F-Outer (between LINK 4 and LINK 5) will be temporarily closed during the hours of 23:00 to 05:00 (Local) to facilitate the provision of new aircraft stand pavement markings. Exact dates and times of works will be promulgated by NOTAM with reference to this Supplement.
